# a. Planning and Facilities

- Amendment 40 our April 2011 meeting was inundated by more than 200 unhappy Bullsbrook residents who were concerned about the LPS 17 Amendment 40 concerning the parking of commercial vehicles. As a result of this meeting BRRA submitted a parliamentary petition to the Upper House and liaised with the Minister for Planning and the City of Swan with respect to changes to that document. The Minister requested the City of Swan make some of these changes before he signed off on the document.
- Pickett Park renewal thank you to Roger for his vision and Cr Kevin Bailey for supporting the initial stages of this project
- Perth to Darwin Highway campaigning
- Facilities planning contribution to document including an FOI corrected misinformation about West Bullsbrook Hall
- Presentation by the Marlin Group re their proposed semirural and urban developments
   State and local government as well as private developers have plans for the growth and
   development of Bullsbrook over the next 20 years. Our population is going to increase and
   BRRA can have a role to play in these developments.

## **b. Community Events**

- West Bullsbrook Hall City of Swan completed an historical investigation of the building and is now listing it.

- there is a legal obligation to engage an independent auditor to audit the grant when completed (there is a cost involved)
- there is an expectation that a person would need to be employed to manage the grant
- plus other requirements as listed in the grant document
- other groups, businesses and organisations may be better placed to manage a grant such as this

Kevin Bailey stated that Linda Richardson from the City of Swan is available to provide assistance relating to reporting if required.

Comments from the meeting included;

- Ngala (from commonwealth) grabbing the money but passing on the responsibility onto local groups
- A lot of work
- Money will stay in Bullsbrook
- BRRA still do events which require no reporting or overheads
- Our events will not achieve grant outcomes
